G-NETS Senior Officials Meeting



On Nov. 28-29, the G-NETS Senior Officials Meeting was held with the participation of 31 cities from Europe, Asia, Africa, the Americas and Oceania. At this meeting, sessions were held on the themes of "Inclusive and Just," "Safe and Secure Cities" and "Environment." Along with sharing knowledge and strengthening collaborative relations, preparations were undertaken for the communiqué to be released at next February's mayor/governor level meeting.

The G-NETS mayor/governor level meeting will be held from February 27 through March 1, with sessions scheduled to also be streamed online. Please look forward to it.

•New systems concerning solar PV systems, heat insulation and energy-saving performances that target newly built homes and other buildings to be launched





In order to not only save electricity, but also generate and store it, the TMG will introduce the following systems from April 2025.

Business operators

Major home builders, etc.,* will be obligated to install solar power generation equipment on newly built homes and buildings in Tokyo, secure their heat insulation and energy-saving performances, and take other such initiatives.

*Major house suppliers and other such companies that supply over 20,000 sqm of housing on a yearly basis will be subject to this mandate.

Tokyo residents

Prospective custom-built home owners must strive to reduce impacts on the environment by taking measures necessary for their homes to be environment-friendly. Purchasers, etc., of built-for-sale homes must strive to reduce impacts on the environment by deepening their understanding of buildings that are environment-friendly.
